## ***Cost of Services (effective August 2017)***

### **For shift less 4 hours:**

\$24.00 per hour – Sunday through Saturday

\$36.00 per hour – major holidays

### **For shift 4 hours or more:**

\$20.00 per hour – Sunday through Saturday

\$30.00 per hour – major holidays

### **How are services initiated?**

All it takes is a phone call to the office to begin services. An in-home interview is arranged at the client's home. Family members are encouraged to participate. The purpose of the interview is to fully understand the needs of the client, explain our program and how it can meet their needs, and answer questions and concerns of the client and his/her family. The only scheduling requirements are a two hour shift minimum and a 24 hour notice for cancellation.

### **How are services paid?**

Clients are billed biweekly for services. Services are not covered by Medicare, Medicaid, or private health insurance. Long term health care insurance occasionally covers our services, depending on the policy. Subsidized rates are offered to clients with financial need (maximum 20 hours per week). Referrals from the Illinois Department of Rehabilitation (DRS) are accepted.

### **Who are the caregivers?**

Caregivers are dependable, compassionate individuals who have been interviewed, screened and trained. They are bonded and covered by liability and worker compensation insurance. Caregivers fall under an umbrella of services in the St. John's Home Services Program. They perform in-home care for those seniors who are ill or frail or any individual who needs temporary assistance due to an injury, illness, or accident. They may provide respite care for families needing a break. They may also work as sitters in hospitals or care centers, assisting family.
